Statement of Fact

This design was developed in consultation with Maine Department of Inland Fisheries and Wildlife, and will provide better spawning habitat for brook trout and whitefish. 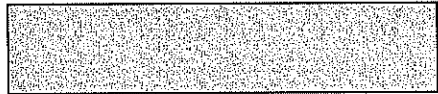

Statement of Fact

This financial order provides allotment for fiscal year 2018-19 to fund one limited-period Chemist II position and one limited-period Chemist III position to be continued in the Health and Environmental Testing Laboratory within the Department of Health and Human Services. These positions were established with Financial Order 004871 F18. Using special equipment previously purchased by the Department of Public Safety, these positions will be charged with transitioning from urine drug testing to blood drug testing for concentrations of controlled substances in those cited for driving under the influence. Limited-period positions will be less expensive and more reliable. Sending samples out of state requires shipping costs and travel and fees for the out of state expert testimony. These positions will address concerns about the State's ability to process new drug cases for prosecution, which is estimated at 2,000 new toxicology cases annually. A formal agreement is planned with the Department of Public Safety for monthly reimbursement of the wages and associated costs. These positions started April 5, 2018 and end March 31, 2020. These positions are funded on a year to year basis.

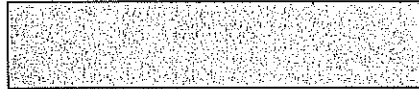

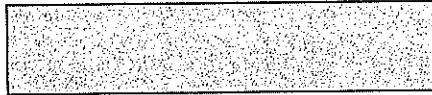



**Statement of Fact**

This allotment will be used to cover the cost of the Public Utilities Commission's monthly payments to Emera Maine for their contractual above-market utility costs. Public Law 2015, chapter 483, sub-§1-6B directs the Public Utilities Commission to pay above-market costs associated with biomass contracts established under this Public Law from the Cost Recovery Fund. This section directs investor-owned transmission and distribution utilities to enter into one or more 2-year contracts for biomass resources. Because the contracts will not end until fiscal year 2018-19, allotment of the estimated unencumbered balance forward is necessary to make payments in fiscal year 2018-19. Failure to approve this order will prevent the Commission from being in compliance with the requirements of the above referenced statute.


